



Schools and Libraries Cybersecurity Pilot Program

Cybersecurity continues to be a growing concern for many schools and libraries across the country. Many of our schools and libraries cite the lack of funding as one of the primary reasons for not investing in the solutions and services necessary to protect their networks and data against cyber threats and criminals. In early June 2024, the Federal Communications Commission (FCC) adopted a preliminary ruling to establish a three-year pilot program under the Universal Service Fund (USF) aimed at supporting schools, libraries, and a consortium of schools and libraries by covering the costs of eligible cybersecurity services and equipment. This program's purpose will be to test the effectiveness of USF funding to determine potential permanent funding for cybersecurity in schools and libraries.

Funding Availability

A total of \$200 million will be available for the three-year pilot period. All awards will be on a pre-E-rate discount basis.

- **For Schools and School Districts:** A minimum of \$15,000 will be available in annual support, with a maximum of \$1.5 million annually.
- **For Libraries:** A minimum of \$15,000 will be available in annual support for up to eleven (11) libraries or sites, with a maximum of \$175,000 annually for library systems with more than 11 libraries or sites.
- **For Consortiums:** A maximum of \$1.5 million will be available for eligible schools, libraries, or both. Funding awards will be based on student count and/or the number of library sites.

Allowable Costs

Eligible projects allowed under this pilot program will center around four types of equipment or services:

1. Advanced/Next-Generation Firewalls
2. Endpoint Protection
3. Identity Protection & Authentication
4. Monitoring, Detection, & Response

Eligibility

Eligible applicants include K-12 school districts (including private and charter school districts), libraries, and a consortium of schools and libraries that meet the eligibility requirements for the E-rate Program. Applicants do not need to be a current or former E-Rate program participant in order to be eligible to apply for the Pilot.

Deadline Information

This program will have a two-part application process. The first application window will open September 17, 2024, and will close November 1, 2024. Only applicants selected in Part One may participate in Part Two, with the Part Two application window being announced at a later date.
